There are 3 mandatory-attendance dates to complete the program: 1) The Kick-off Weekend, 2) The Play-to-Win Weekend and 3) the Residential Retreat (Friday-Sunday).

The Synergy Advanced – General Information

What happens in the Workshop?

You will create a powerful future – allowing life to be lived from what is possible, not from what is predictable or historical. Most participants venture to levels of honesty, teamwork, caring, spontaneity, openness and self-expression, beyond anything they have ever experienced.

The Synergy Advanced Workshop begins where The Synergy Basic left off and includes but is not limited to:

- Incisive coaching from trained Synergy transformational coaches

Breaks

During the five-day workshop session, every 2½ to 3 hours there will be a 20 – 30 minute break for bio needs. In addition, there is one longer meal break each day for approximately 1½ hours occurring generally in the late afternoon to early evening.

Food

Please ensure to eat a sustaining breakfast each day before coming to the workshop. You may wish to bring snack foods to eat during the shorter breaks. You may have bottled water at your seat during the workshop.

Dress

Dress is casual and comfortable. You may wish to dress in layers for possible room temperature changes. You may also wish to dress more formally on Sunday (or bring special attire) for your celebration.

IMPORTANT NOTICES ABOUT THE WORKSHOP

1. Synergy Education, Inc. ("Synergy") delivers training that is designed for everyone interested in enhancing their skills of **leadership, partnership, and productivity**. Participants learn to become unstoppable in their work and life by designing a **vision** that reflects their highest standards and ideals.
2. The Program is experiential, philosophical and educational in nature. While it is not possible to completely describe everything that may occur during the Program, it generally consists of: Interactive Group Discussions, One on One Discussions, Small Group Exercises, Closed-Eye Processes, Voluntary Sharing, and Interactions with the Synergy Trainer.
3. It is possible that, from time to time during the Program, participants may find they are uncomfortable or challenged, or May experience emotions.
4. The Program is not designed to and should not be taken to resolve emotional problems for which therapy or similar treatments are generally used. The Program is not nor is it intended to be psychotherapy or medical therapy or a substitute for either one.
5. The Program is led by Synergy's trainers, who are responsible only for delivering the material of the Program as it was designed.
6. Synergy's trainers have extensive training and experience in coaching individual effectiveness, with the aim of helping participants determine and achieve personal goals. Synergy's trainers

are not licensed therapists or psychologists. No trained or licensed health care professionals will be available to assist you in their professional capacity during or at the Program.

7. The Program May involve long hours of intense conversations and topics. While Synergy's intention is always to empower and support participants in this experience, it's important to understand that, by its very nature the Program is designed to have participants question what they have come to know about their lives and confront powerfully the choices they've made.
8. There are scheduled breaks during the day; however, the timing of those breaks may vary. Participants are responsible for their own well-being prior to, during, and after the Program, and are free to leave the Program room at any time.
9. Participants in the Program should notify the trainers or other Synergy personnel or volunteers at the Program if they experience any physical, mental, or emotional discomfort during the Program.
10. Synergy and its trainers reserve the right throughout the entire Program to exclude or remove participants from the Program for any reason. In such instances, Synergy will refund the tuition of any participant so excluded.

You must indicate your acceptance of these, by signing below, before participating in the Program.

Intellectual Property

All materials, displays, manuals, handouts, concepts, processes, documentation, data and other information (collectively "Program Materials") presented during or in any way related to the Program, whether presented in tangible or intangible form, orally or in writing or in electronic, digital, magnetic, or any other form, are the exclusive property of Synergy, whether or not said Program Materials are or have been published, patented, trademarked, copyrighted, or registered, or are suitable therefore. The Program Materials represent valuable and confidential intellectual property and are presented solely for the participants' personal use and development while participating in the Program.

As a condition for my participation in the Program, I agree not to reproduce, copy, repackage, or duplicate in any way the Program Materials, nor distribute, lend, or otherwise transfer any of the Program Materials to anyone else, nor teach what I learn in the Program to anyone else, nor in any way adapt the Program Materials for use or delivery in my own business, without the prior written consent of Synergy.

Confidentiality

Synergy respects the privacy and confidentiality of the Program participants, and is committed to providing a comfortable and safe environment for the Program. Arbitration
